### **POSITION VACANCY:** Computer Technology Instructor – 10 Month, Job #08-67

Fayetteville Technical Community College is seeking qualified applicants for this full-time position. The ability to effectively teach classroom/laboratory courses in the Computer Technology Division in one or more of the following areas: applications (MS Office, Adobe Suite, 3DS Max), hardware and software (A+ Prep classes), networking (Cisco, Linux, Novell, Microsoft), operating systems, and security is critical to experiencing success in this position. Qualified candidates will possess excellent computer skills; demonstrate evidence of a career that includes flexibility and willingness to change; open-mindedness, fairness and the ability to see multiple perspectives; a willingness to take risks, and willingness to accept responsibility for professional and personal growth.

### **DUTIES:** The successful candidate will:

- Teach face-to-face classes to include days, evenings, and weekends both on and off campus.
- Teach online classes as needed by the Division.
- Incorporate latest instructional technologies & interactive learning technologies in course delivery.
- Advise students who are in the Computer Technology Division programs.
- Participate in faculty committees and other activities, as assigned.

**QUALIFICATIONS: Minimum Requirements:** Associate Degree in a Computer Technology related discipline. Communication, both oral and written, and advanced computer skills necessary. **Applicants not meeting these minimum requirements will not be considered for this position. Preferred:** Teaching experience at the community college or four-year college. On-line teaching experience. Master's Degree or pursuit of a higher degree and industry certifications.

Degrees **MUST** be from a regionally accredited institution that is recognized by the Department of Education. Transcripts **MUST** show degree earned and date conferred. **A resume will not be considered in lieu of an FTCC application.**

**COLLEGE & COMMUNITY INFORMATION:** FTCC, North Carolina's third largest community college, is located in Cumberland County, NC, population of approximately 314,000, and is home to the Airborne and Special Operations Museum, Cape Fear Botanical Garden, Museum of the Cape Fear, and wineries. The area is a mecca for hiking, fishing and golf enthusiasts. Downtown Fayetteville has undergone a trendy revitalization to include restaurants, boutiques, art galleries, community theaters, the Fayetteville Symphony, town homes and condo living. Proximity to the ocean is 2 hours and 3.5 hours to the mountains. The Cumberland County School System has many award winning schools and was named a 2008 first place winner by the American Board Association in the National Magna Awards Program.

Cumberland County is also located in "The All American Defense Corridor" and is home to the US Army's Fort Bragg. This area is experiencing huge expansions in population, available jobs, research and development due to the Base Realignment and Closure (BRAC), which will make Fort Bragg the largest Army post in the US. It is anticipated that by year 2013, 54,000 new jobs will be created which will significantly affect economic development and the growth and expansion of FTCC.
